#### 5. FIRE-FIGHTING MEASURES

Specific hazards arising from

Special protective equipment and precautions for firefighters: Water spray, fog, CO2, dry chemical, or alcohol resistant foam. Do not use a solid water stream as it may scatter and spread fire. Fire may produce irritating, corrosive and/or toxic gases.
