Methods and materials for containment and cleaning up:

Collect and dispose of spillage as indicated in section 13 of the SDS. Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk. Dike the spilled material, where is this possible. Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Prevent product from entering drains. Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where is this possible. Cover with plastic sheet to prevent spreading. Absorb vermiculite, dry sand or earth and place into containers.
